## California Regional Apprenticeship Strategy Sessions


To launch and inform the Center's focused work in the state of California to advance registered apprenticeship (RA) alignment, <u>Safal Partners</u>, the <u>California Workforce Association</u> (CWA), the <u>California Division of Apprenticeship Standards (DAS)</u>, and the California <u>US Department of Labor Office of Apprenticeship (USDOL OA)</u> formed a Leadership Team of 26 members from industry, workforce, education, government, and labor, with representation at both state and local levels.



The team determined that a series of regional RA strategy sessions convening key stakeholders from education (K-12, post-secondary, and adult education), workforce (state and local workforce development boards), industry, labor, and community-based organizations would both facilitate delivery of key alignment-oriented technical assistance (TA) and accelerate strategic partnership formation around apprenticeship.

Three sessions were held in the northern region (Sacramento - 8/2), central region (Clovis - 8/4), and southern region (Long Beach - 8/9). Representatives from DAS, including Division Chief Eric Rood, and the Foundation of California Community Colleges provided state-specific RA background and updates before an engaged working session facilitated by Safal Partners SMEs. A total of 258 participants across each targeted constitutency group (see below) actively collaborated in creating locally-informed and participant-driven action plans to accelerate RA adoption and alignment forward for their area. This approach allowed

participants who are currently engaged in apprenticeship at varying levels to build and strengthen partnerships for RA acceleration and modernization.



The Center created an initial session report out which it has shared with the CA Leadership Team and USDOL OA. Center SMEs are doing follow-up outreach to session attendees and will coach working groups through the Fall until a virtual reconvening in January 2023.

### New Tool, Webinar Series on Driving System Alignment

National Disability Institute (NDI), a national partner on the Center of Excellence has developed an "Apprenticeship Driver Alignment Assessment" for leadership teams for use in evaluating system alignment. Doug Keast, Project Manager at NDI,



recently spoke about the assessment tool on a three-part webinar series hosted on Center partner NAWDP's "30 Minutes of Excellence" series.

## Aligning Workforce to Accelerate Youth Apprenticeship

CWA MMM Session with San Joaquin County, CareerSource USA

As part of its work to increase apprenticeship alignment with education and workforce systems, the Center presented on "The WHAT and WHY of Youth Apprenticeship" at CWA's annual Meeting of the Minds (MMM) conference held on September 6th-8th.

The panel session, moderated by Adam Peck, Executive Director of the Tulare County Workforce Board, featured federal and state leaders in youth registered apprenticeship work including:

- Katie Wipfli Director of College and Career Readiness, San Joaquin County Office of Education

Long-term structural changes in the nation's labor market, as well as projected long-term drop in both birth rates and workforce participation, are drivers for the increased focus on youth apprenticeship. In addition to being aligned with the Workforce Innovation and Opportunity Act (WIOA), youth apprenticeship is a proven strategy for getting students both work-ready for day-one employment post-high school, as well as providing them with industry-aligned knowledge, workplace experience, and industry-valued credentials prior to graduation. Katie Wipfli shared <a href="San Joaquin County's ARCH Program">San Joaquin County's ARCH Program</a>, which dovetails education and workforce and can serve as a replicable model for youth apprenticeship. The Center will be releasing a new Promising Practice resource on the program next quarter.
