The Center has created a draft tool designed to help local workforce boards assess their potential "level" of alignment with RA and identify clear next steps for utilizing RA to meet local employment needs while also meeting critical Workforce Innovation Opportunity Act (WIOA) performance metrics. New RA Academy Module on WIOA Credential Attainment Rate (CAR) and RA



The new **DOL RA Academy** provides customized education and training on foundational RA topics for key stakeholder groups. The Academy recently posted a new module on the use of WIOA funding for RA programs that may last longer than WIOA services are available. This timeline to access WIOA funding has caused

some hesitancy on the part of boards to utilize WIOA to support RA. Maria Remboulis Brady discusses opportunities for local boards and their One-Stop Operators to achieve positive outcomes on the WIOA CAR while supporting longer-term RA programs by offering interim credentials or other industry-recognized certifications. Identifying Apprenticeship Networks Nationwide

The Center is seeking your assistance in identifying active and naturally established (generally non-DOL funded) apprenticeship networks.

Apprenticeship Colorado Opportunity to Accelerate and Expand RA Through Intermediaries



As part of state legislation (HB21-1007), the Colorado State Apprenticeship Agency (SAA), Apprenticeship Colorado, recently announced a statewide initiative to recognize "Qualified Apprenticeship Intermediaries" which will be eligible for competitive funding opportunities and other benefits. Organizations can apply for recognition as either an Industry Apprenticeship Intermediary (focusing on

serving employer needs) and/or **Talent Apprenticeship Intermediary** (focusing on carer seeker and apprentice needs). Public and private entities are encouraged to apply. Learn more including state funding opportunities to support registered apprenticeship expansion **on the SAA's website**.

DOL Apprenticeship Ambassador Initiative Accepting Applications for Next Cohort

The <u>Apprenticeship Ambassador</u> <u>Initiative</u> creates a national network of employers, labor organizations, worker advocates, industry associations, program sponsors,



educators, workforce intermediaries, community-based organizations, and other stakeholders to serve as champions for modernizing, expanding, and diversifying RA. Since the Initiative was launched in 2021, the U.S. DOL has selected over <u>300</u> **Ambassadors**.

RA sponsors, employers with RA experience, related technical instruction providers, sponsors of pre-apprenticeship programs that lead to RA, and community-based organizations who have seen the value and benefits of RA, are encouraged to check out the <u>Apprenticeship Ambassador Initiative</u> website for more information and <u>submit an application</u>.
