Increase RA partnerships

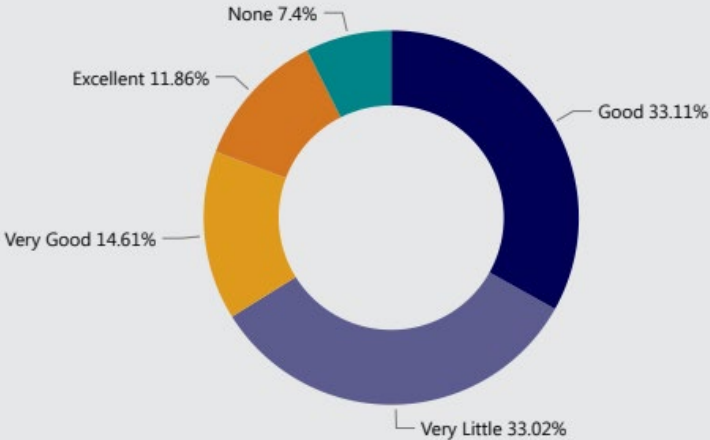

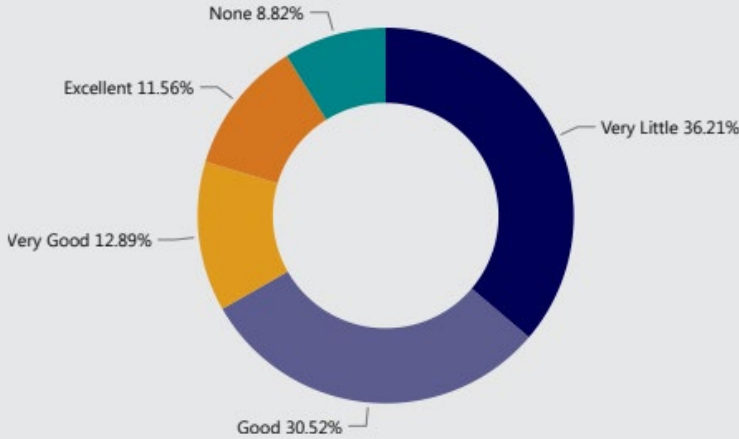


Challenge #1: Workforce System Knowledge of RA

Challenge #2: RA Inclusion in WIOA Plans

Comprehensive WIOA State Plan Analysis

First-ever analysis of all 50 2020, 2024 WIOA State Plans for RA alignment with multi-part webinar sessions on WIOA state planning for RA

- Learn from states whose plans reflect strong WIOA and RA alignment
- Implement recommendations for state, local WIOA Plan focus on RA



Indicators of RA Alignment in WIOA Plans:

▶ Baseline: RA mentioned as workforce strategy

1. Plan to utilize state and federal grants to expand RA
2. RA specifically articulated in strategy to meet State and local plan vision
3. State level RA work group or committee to State Workforce Board
4. RA expertise embedded in AJCs
5. State and local level initiative with investments for RA expansion
6. Specific objectives, goals for increased # of apprentices or new RA programs

- Improve industry partner engagement on RA through IET

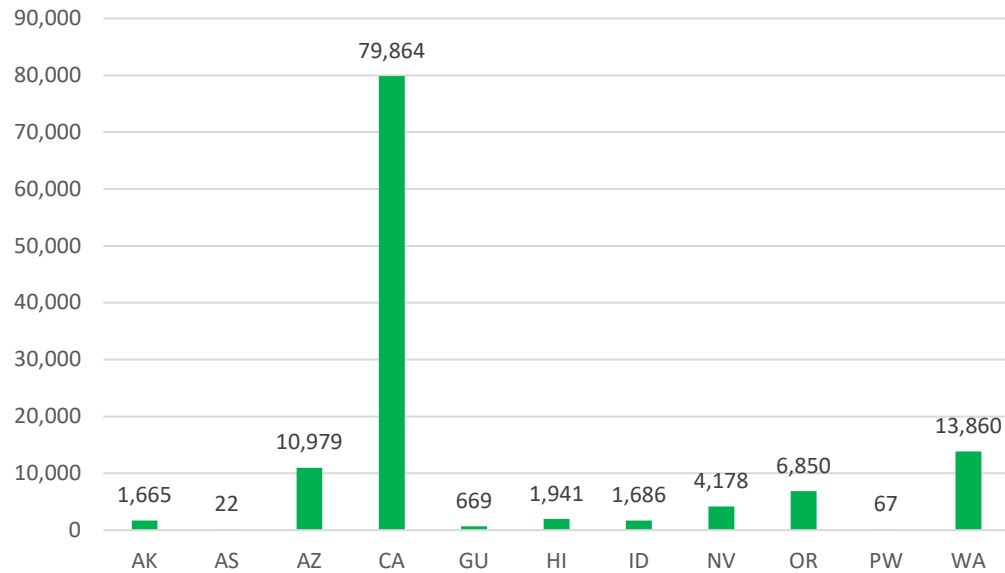

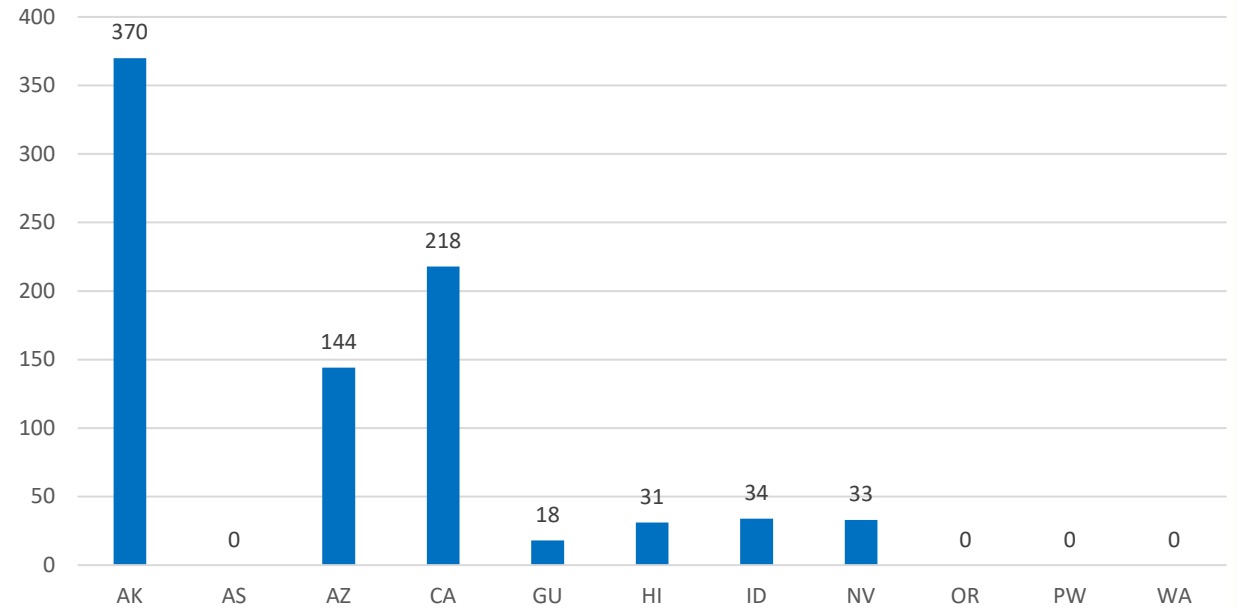


Challenge #5: WIOA Title I / RA Co-Enrollment

Total WIOA Title 1 (Adult, Dislocated Worker, Youth) Enrollment



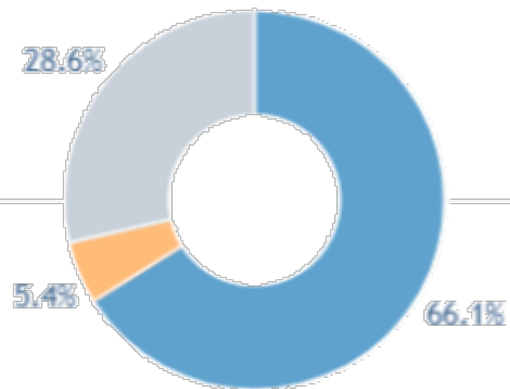
WIOA/RA Co-Enrollment Total # (PIRL 931)

Opportunities for Workforce Systems

- **Plan:** Proactively plan to utilize WIOA, grant funding to support RA
- **Develop Partnerships:** Meet to determine how each partner can use, leverage and braid program funding, resources, and services for RA.
- **Engage RA System:** Collaborate with local DOL OA/SAA staff on regular basis
- **Review Reporting:** Ensure accurate data to reflect the impact of WIOA on Registered Apprenticeship
- **Build Pre-Apprenticeship Pipelines:** Pre-apprenticeship bridge programs are important, especially for youth
- **Use RA Intermediaries:** Access help for outreach, technical assistance, funding, program sponsorship, etc. to launch and sustain RA programs
