

What is Youth Registered Apprenticeship?

- An industry-driven, high-quality, "earn and learn" model for in-school and outof-school youth between the ages of 16
 24
- Bridges the classroom and workplace
- Enables employers to engage earlier with students to prepare them for full time work
- Provides students with mentor-led, paid work-based learning resulting in a portable, national credential

Why Now?

- Increased need for work-ready employees in tight job market
- Provides structured plan for shrinking skills gaps
- Student and parent concerns around student loan debt (apprenticeship as the "debt free" college alternative)
- Provides employers with important tool
 - by creating access to broader sources of talent



How WIOA and Youth Apprenticeship Align

- Promotes partnership strategies between education, workforce and industry
- Strengthens worker pipelines by engaging and preparing students earlier in their academic careers to meet local/regional sector workforce needs
- Gold standard in work-based learning approach that builds student/worker skills and gets youth on career pathway to higher-quality, higher-paying jobs
- RA sponsors are on state ETPLs, establishing opportunity for investing WIOA resources in related training component of youth RA programs
- Focus on skill building directly maps to Measurable Skills Gains performance metric



Youth Apprenticeship and WIOA Performance Metrics

Benefits of WDBs engaging in Youth Apprenticeship:

- Helps meet Workforce Innovation and Opportunity Act (WIOA) performance measures including Youth Education and Employment rates for both 2nd and 4th quarter (94% of all apprentices who complete a program are hired as full-time workers and 91% are still with their employer a year out)
- Provides your board with the knowledge that RA skills training meets your local business needs, since it is employer-driven, while giving you the credential performance measure
- Ensures higher median earnings after 2nd quarter performance metric is met, especially since apprentices receive a raise during their apprenticeship
- Provides a measurable skills gain after completion of one year of the program



Youth Apprenticeship in Missouri

- DHEWD
- As of April 2022:
 - 24 high schools and CTE programs are youth RA sponsors
 offering a total of 86 programs with 112 registered inschool youth apprentices
 - 13 Missouri colleges and universities are RA sponsors offering a total of 49 programs for both youth and adults



RA TA Center of Excellence

- Awarded to Safal Partners in July 2021
- Focus: Building sustainable partnerships to support system alignment of the national workforce and education systems to accelerate Registered Apprenticeship adoption.
- Work: Providing technical assistance on a national scale by drawing on proven innovation at the local level to accelerate adoption and integration of Registered Apprenticeship with workforce and education systems.



Three primary tasks:

- Providing TA on a National Scope
- Engaging Key Stakeholders
- Coordinating with Federal and State Investments
